Elder law is defined by the client to be served. In other words, the lawyer who practices elder law may handle a range of issues but has a specific type of client, seniors. Elder law attorneys focus on the legal needs of the elderly and work with a variety of legal tools and techniques to meet the goals and objectives of the older client.

Preservation / transfer of assets in order to avoid impoverishment.

- Disability planning, including use of durable powers of attorney, living trusts, living wills, for financial management and health care decisions
- Conservatorships and guardianships
- Estate planning – The preparation of a plan of administration and disposition of one's property before or after death, including will, trusts, gifts, power of attorney, etc.
- Administration and management of trusts and estates
- Long-term care placements in nursing home and life care communities
- Nursing home issues including questions of patients' rights and nursing home quality
- Benefits, survivor benefits and pension benefits

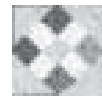
